Semakin Memikat, Laba Bersih TINS Tumbuh 87%

Jakarta, 8 November 2022 – PT TIMAH Tbk (“Perseroan”; IDX: TINS) hari ini mengumumkan Laporan Keuangan Konsolidasian Interim untuk periode yang berakhir 30 September 2022.

Perseroan berhasil membukukan laba bersih pada 9M22 sebesar Rp1.146 miliar, naik 87% dibandingkan 9M21 sebesar Rp612 miliar. Kenaikan kinerja Perseroan ini didorong oleh meningkatnya harga jual logam timah, efisiensi di seluruh rantai bisnis, penurunan *interest bearing debt* dan konsistennya peningkatan kinerja anak usaha segmen non pertimahan.

Kinerja Operasi

Produksi bijih timah pada 9M22 tercatat sebesar 14.502 ton, turun 19% dibandingkan periode 9M21 sebesar 17.929 ton. Dari jumlah tersebut 35% atau 5.004 ton berasal dari penambangan darat, sedangkan 65% atau 9.498 ton berasal dari penambangan laut. Produksi logam timah pada 9M22 tercatat sebesar 14.130 metrik ton, turun 26% dibandingkan periode 9M21 sebesar 19.120 metrik ton.

Penjualan logam timah pada 9M22 tercatat sebesar 15.325 metrik ton, turun 20% dibandingkan periode 9M21 sebesar 19.059 metrik ton. Meski volume penjualan menurun, Perseroan mencatatkan harga jual rerata logam timah pada 9M22 sebesar USD35.026 per metrik ton, naik 16% dibandingkan periode 9M21 sebesar USD30.158 per metrik ton.

Kinerja Keuangan

Perseroan berhasil merealisasikan peningkatan kinerja keuangan hingga Kuartal III tahun 2022 dengan mencatat pendapatan naik 5% menjadi sebesar Rp10,2 triliun (9M21: Rp9,7 triliun), laba operasi naik 26% menjadi sebesar Rp1,5 triliun (9M21: Rp1,2 triliun), EBITDA naik 21% menjadi sebesar Rp2,2 triliun (9M21: Rp1,8 triliun).

Posisi nilai aset Perseroan pada Kuartal III tahun 2022 sebesar Rp13,3 triliun, turun 10% dibandingkan posisi akhir tahun 2021 sebesar Rp14,7 triliun. Posisi liabilitas sebesar Rp6,1 triliun, turun 27% dibandingkan posisi akhir tahun 2021 sebesar Rp8,4 triliun. Posisi ekuitas sebesar Rp7,1 triliun, naik 13% dibandingkan posisi akhir tahun 2021 sebesar Rp6,3 triliun.

Posisi kas dan setara kas Perseroan naik 27% menjadi Rp1,4 triliun dari periode yang sama tahun sebelumnya Rp1,1 triliun. Pinjaman bank, liabilitas *supplier financing* dan utang obligasi turun menjadi Rp3 triliun dari sebelumnya Rp5,1 triliun.

Indikasi baiknya performa finansial Perseroan terlihat dari beberapa rasio seperti *Quick Ratio* sebesar 43%, *Current Ratio* sebesar 191%, *Gross Profit Margin* sebesar 22%, *Net Profit Margin* sebesar 11%, *Debt to Asset Ratio* sebesar 22%, dan *Debt to Equity Ratio* sebesar 42%.

“Perseroan optimis dapat membukukan kinerja positif hingga akhir tahun 2022. Perseroan akan terus konsisten menjalankan efisiensi di seluruh rantai bisnis, serta mendorong peningkatan kinerja anak usaha”, demikian disampaikan Direktur Keuangan dan Manajemen Risiko PT TIMAH Tbk, Fina Eliani.

Getting Attractive, TINS Net Profit Grow Up To 87%

Jakarta, November 8, 2022 – PT TIMAH Tbk (“the Company”; IDX: TINS) today announced its Interim Consolidated Financial Statements for the period ended on September 30, 2022.

The Company managed to record net profit in 9M22 of Rp 1,146 billion, an increase of 87% compared to 9M21 of Rp612 billion. This increase in performance was driven by increased tin metal selling prices, efficiency throughout business chain, decreased of interest bearing debt and consistently improved performance of non-tin segment subsidiaries.

Operation Performance

Tin ore production in 9M22 was recorded at 14,502 tons, decreased by 19% compared to 9M21 of 17,929 tons. Of this amount, 35% or 5,004 tons was from onshore mining, while 65% or 9,498 tons was from offshore mining. Tin production in 9M22 was recorded at 14,130 metric tons, decreased by 26% compared to 9M21 of 19,120 metric tons.

Refined tin sales in 9M22 was 15,325 metric tons, decreased by 20% compared to 9M21 of 19,059 metric tons. Despite the declining sales volume, the Company announced the average selling price of refined tin in 9M22 of USD35,026 per metric tons, an increase of 16% compared to 9M21 of USD30,158 per metric tons.

Financial Performance

The Company was able to present outstanding financial performance until the third quarter of 2022 by announcing its revenue increased by 5% to Rp10.2 trillion (9M21: Rp9.7 trillion), operating profit increased by 26% to Rp1.5 trillion (9M21: Rp1.2 trillion), EBITDA increased by 21% to Rp2.2 trillion (9M21: Rp1.8 trillion).

The position of the Company’s asset value in the third quarter of 2022 was Rp13.3 trillion, decreased by 10% compared to end of 2021 amounted Rp14.7 trillion. The liabilities position is Rp6.1 trillion, decreased by 27% compared to the end-year position of Rp8.4 trillion. The equities position of Rp7.1 trillion, an increase 13% compared to the year-end position of Rp6.3 trillion.

The Company’s cash and cash equivalents increased by 51% to Rp1.4 trillion from the same period last year of Rp1.1 trillion. Bank loans, supplier financing liabilities and bonds payable fell to Rp3 trillion from the previously of Rp5,1 trillion.

Indication of the Company's good financial performance can also be observed from several ratio's such as Quick Ratio of 43%, Current Ratio of 191%, Gross Profit Margin of 22%, Net Profit Margin of 11%, Debt to Asset Ratio of 22%, and Debt to Equity Ratio of 42%.

"The Company is optimistic that it can record a positive performance until the end of 2022. The Company will continue to be consistent in carrying out efficiency throughout business chain and encourage increased performance of subsidiaries", said Director of Finance and Risk Management at PT TIMAH Tbk, Fina Eliani.
