Stakeholders Engagement

Perseroan telah melakukan identifikasi pemangku kepentingan di seluruh wilayah operasional berdasarkan metodologi identifikasi yang sesuai dengan AA100 Stakeholder Engagement Standard (AA100SES) dan ISO 26000. Dalam proses identifikasi ini, beberapa kelompok pemangku kepentingan yang memiliki pengaruh langsung terhadap keberlanjutan Perseroan. Pelibatan pemangku kepentingan dilakukan melalui metode beragam, dengan pendekatan pemenuhan kebutuhan untuk memberikan alternatif penyelesaian terhadap keluhan yang disampaikan oleh setiap pemangku kepentingan.

The Company has conducted stakeholders identification across all operational sites based on an identification methodology in line with the AA100 Stakeholder Engagement Standard (AA100SES) and ISO 26000. In this identification process, several stakeholder groups with direct influence on the sustainability of the Company were identified. Stakeholders engagement is carried out through various methods, with a need-based approach to provide alternative solutions to address concerns raised by each stakeholders.
